At the **2010 synod assembly (June 18-19)**, elections will be held to fill positions on the Synod Council, Philadelphia Seminary Board, Committee on Discipline, and Consultation Committee. Your nomination of persons to fill these positions is welcomed and encouraged. In addition, voting members will be elected to the ELCA Churchwide Assembly in Orlando FL, on August 14-20, 2011. Your nomination of persons to fill these positions is welcomed and encouraged. Please use this form and photocopy it for multiple use. The deadline to submit names to the Nominating Committee is **March 31, 2010**.

Three three-year terms on Synod Council will be filled: one clergy, one lay female, one lay male. Other Synod Council positions to be filled are two lay persons of color or primary language other than English (female, one year; male, three years) and youth (female, two years; male, one year). One seat on the Philadelphia Seminary Board will be filled: clergy. Five terms on the Consultation Committee will be filled: one five-year term (clergy); one three-year term (clergy); two-, four- and six-year terms (lay). Four six-year terms on the Committee on Discipline will be filled: two clergy, one lay male, one lay female.
